# Fake ChatGPT Study Fools Scientists

**NEW DELHI:** An AI chatbot called ChatGPT has written convincing fake research paper abstracts that scientists were unable to spot, a new research has revealed. A research team led by Catherine Gleason at Northwestern University in Chicago used ChatGPT to generate artificial research paper abstracts to test whether they can spot them. These abstracts fooled 33% of the scientists, which is a median originality score was 70%, which indicates that no plagiarism was detected. The AI output detector spotted 66 per cent of the generated abstracts. But the human reviewers didn't do much better - they correctly identified only 68% of the generated abstracts and 66% of the genuine abstracts. They incorrectly identified 33% of the generated abstracts as being real and 14% of the genuine abstracts as being generated, according to the Nature article. - Agency
