Pursuant to the resolution passed by the Board of directors of **Inani Marbles & Industries Limited** (hereinafter referred to as "company") on 08<sup>th</sup> August, 2022, I had been appointed as the scrutinizer for the remote e-voting process and polling to be carried out at the Annual General meeting (hereinafter referred to as "AGM") in fair and transparent manner and ascertaining the requisite majority in respect of the resolutions contained in the notice to the AGM of the members of the company.

To enable wider participation of equity shareholders, pursuant to the provisions of section 108 of the Companies Act, 2013 and rules framed thereunder vide The companies (Management and administration) Rules, 2014 including The companies (Management and Administration) Amendment Rules, 2015, dated March 19, 2015 and SEBI's circular no.CIR/CFD/DIL/6/2012, dated July 13, 2012 as amended by its circular CIR/CFD/POLICYCELL/2/2014 dated April 17, 2014, every company having its equity shares listed on recognized stock exchange, is required to provide remote e-voting facility to their shareholders on all shareholders' resolutions to be passed at general meeting or through postal ballot. Since the company falls within the requirements as specified in the Companies Act, 2013 and the above mentioned circular of SEBI, remote e-voting which has been made applicable, the company provided for the same.

The company accordingly made arrangements with the system provider Central Depository Services (India) Limited (herein after referred as "CDSL"), depository for providing a system of recording votes of the shareholders electronically through remote e-voting. The company has also accordingly made arrangements through its Registrar and Transfer Agent, Ankit Consultancy Pvt. Ltd. (herein after referred as "RTA") to set up the e-voting facility on the CDSL e-voting Website <https://www.evotingindia.com>.

The company through RTA has also uploaded the resolutions in which remote e-voting is required and for generating Electronic Voting Sequence Number (EVSN) by the system provider. All necessary formalities in compliance with the requirements specified by CDSL, the system provider has been done by the company through its RTA. Necessary instructions in this regard to be followed by the shareholders had also been duly mentioned in the AGM notice dated 08<sup>th</sup> August, 2022. The members of the company as on the cut- off date i.e. 22<sup>nd</sup> September, 2022 were entitled to vote on the resolutions contained in the notice to the AGM of the members of the company.

Further to the above, I submit my report as under: -

1) As confirmed by management, the AGM notice dated 08<sup>th</sup> August, 2022 under section 101 of the Companies Act, 2013 was dispatched to 2663 (Two Thousand Six Hundred and Sixty Three) shareholders (cutoff date for sending AGM notice is August 26, 2022) by electronic means via e-mail respectively on or before 06<sup>th</sup> September, 2022.

2) As stated in sub rules 4 of rule 20 of the companies (Management and Administration) Amendment Rules, 2015 amending the Rule 20 of the (Management and Administration) Rules, 2014 an advertisement was published by the company on 07<sup>th</sup> September, 2022 in "The Economic Times" English newspaper and "Business Remedies", vernacular newspaper, informing about the completion of the dispatch of the AGM notices, by electronic means via e-mail, to the shareholders along with other related matters mentioned therein.

3) The remote e-voting period remained open Monday, 26<sup>th</sup> September, 2022 at 09:00 A.M. and ends on Wednesday, 28<sup>th</sup> September, 2022 at 05:00 P.M.

4) The members of the company as on the cut-off date i.e. 22<sup>nd</sup> September, 2022 were entitled to vote on the resolutions.

5) The empty polling box was locked and sealed in the presence of members. After the conclusion of voting at AGM, votes cast at the meeting were counted first and the votes cast through remote e-voting were unblocked in the presence of 2 witnesses who are not in the employment of the company.

6) The total number of fully paid up shares of the company outstanding as on 22<sup>nd</sup> September, 2022 were 18600000. As on cut-off date, out of 2677 shareholders, 24 (Twenty Four) shareholder has exercised their votes through remote e- voting and 16 (Sixteen) shareholders has exercised their vote through poll at the AGM.
