**Constable arrested for accepting ₹5L bribe in Bharatpur**

JAIPUR: A constable of police intelligence was arrested on Wednesday for allegedly accepting a bribe of ₹5 lakh in Rajasthan's Bharatpur district, an Anti-Corruption Bureau (ACB) official said.

The accused constable, Sanjay Singh, had demanded ₹1 crore bribe from a B.Ed college owner, stating that someone had lodged a complaint of scams and irregularities at his college located in Hindaun city, ACB Director General of Police Alok Tripathi said.

The accused threatened the complainant to give ₹1 crore to settle the case but the deal was fixed at ₹45 lakh, he said.

The complaint was verified and a trap was laid on Wednesday following which the accused was caught red-handed by the ACB officials. **PTI**
