MAN FALLS INTO  
15-FOOT-DEEP

**JAIPUR:** A man died after falling into a borewell in Dausa district of Rajasthan on Friday, police officers aware of the matter said on Saturday.

Hemraj Gurjar, 44, was trying to remove a motor stuck in the borewell in his agricultural field when the soil caved in and he fell inside, deputy superintendent of police (DSP) Dilip Meena said.

With the help of earthmovers, local villagers and police personnel, Hemraj was taken out from the 15-feet-deep borewell in an unconscious state and rushed to the district hospital, where doctors declared him brought dead, he said.

The body has been kept in the mortuary for post-mortem examination, which will be done on Saturday, the DSP said.

## State govt is promoting aviation sector, says CM

**JAIPUR:** Rajasthan chief minister Bhajan Lal Sharma on Saturday said that the government is promoting the state's aviation sector by developing new airports, heliports, flying training schools and maintaining hubs that will drive tourism and strengthen the state's economy.

Sharma was speaking while inaugurating the new terminal building which has been given a heritage look.

The new terminal has an annual capacity of 1.5 million passengers. The Jaipur airport now has two terminals — Terminal 1 will handle international flights and Terminal 2 is slated for domestic flights.

Speaking at the inauguration ceremony, Sharma said, "The current capacity of the new terminal is 65 lakh which is expected to increase to 3.8 crore in the coming years. This will be a big achievement and will be beneficial for Rajasthan. As trade and tourism expands, it will boost the state's economy and help us achieve our promise of 'Viksit Rajasthan'."

Sharma said that the inauguration of the airport was oppor-

tune as the Rising Rajasthan investment summit slated for December 9, 10 and 11 will see industrialists and investors from around the world converge in Jaipur.

Sharma underlined his government's effort to increase both investment and tourism in Rajasthan, which will benefit the state. "Whenever I visit districts, I emphasize upon developing more tourist sites and providing good facilities so tourists will feel compelled to stay, which will

benefit the state. We should create cultural centres and religious circuits to attract tourists," he said.

"During my visit to different countries for Rising Rajasthan, I highlighted the potential for tourism in the state... we have many forts, palaces, desert, lakes, wildlife sanctuaries, religious sites, so the airport will be an advantage to the state," said Sharma.

He said seven airports, including Jaipur, are being developed

in the state.

"We are working to develop and provide better facilities in these airports. The state terminal in Jaipur airport will be developed. The Jodhpur airport and air strips in Udaipur, Sriganganagar, Jhalwar are being developed. We plan to begin regular flights from Kota, Jaisalmer and Bikaner airports soon. Creating this strong foundational framework will provide more job opportunities for the youths," he said.

Sharma mentioned that flying training schools too would be opened in the state. "We have to cover the shortage of trained pilots and for that we opened the first flying training school in Kishangarh. Training schools are also planned at Hameerghar in Bhillwara and in Jhunjhunu."

Sharma said his government had slashed tax on aviation fuel from 26% to 2%, which has benefited the state as more and more cargo flights are coming to Rajasthan. To give a fillip to heli tourism, heliports are being developed in all border districts, the CM said. He said heliports will be created in each district that will cater to tourists who want to maximise their travel in the minimum time possible.

## Cong steps up to pacify leaders denied tickets

**JAIPUR:** A day after the final day of filing nomination, the Congress on Saturday embarked on a damage-control exercise by roping in senior leaders to broker peace with at least six rebels who did not get tickets for the upcoming bypolls, people aware of the matter said.

Rajasthan is going to the bypolls in at least seven assembly seats in Dausa, Deoli-Uniyara, Khinvsar, Jhunjhunu, Salumber, Chorasai and Ramgarh on November 13. However, the party is facing strong opposition in at least three of these seven seats — Deoli-Uniyara, Salumber, and Khinvsar.

While young party leader Naresh Meena filed his nomination against the party's official candidate KC Meena in Tonk's Deoli-Uniyara, another leader from Khinvsar Durg Singh Chauhan also switched to the BJP on Friday night, expressing his discontent over the nomination of Ratan Chaudhary.

The party's senior leader and two-time candidate from Salumber, Raghuvver Singh Meena, also expressed strong opposition of Reshma Meena's nomination in the bypoll and remained elusive during the party campaigns. Two block presidents in the constituency have also resigned

from the party on Thursday soon after the candidates were announced.

On Wednesday night, the party declared candidates for all the seven seats, pushing fresh faces, including family ties in two. In an official list issued by the party's national general secretary KC Venugopal, the Congress picked the son of Jhunjhunu MP Brijendra Ola's son Amit Ola, and late MLA Zubair Khan's son Aryaan Khan from Ramgarh constituency in Alwar.

The party has also named the wife of former IPS officer Sawai Singh Chaudhary's wife Ratan Chaudhary from Nagaur's Khinvsar constituency, KC Meena from Tonk's Deoli-Uniyara, Deen Dayal Bairwa from Dausa, Reshma Meena from Salumber (ST), and Mahesh Roat from Chorasai (ST).

KC Meena is likely to face a strong contest from the young party leader Naresh Meena, who was also a key aspirant from the

seat and also filed his nomination as an Independent candidate from Deoli-Uniyara on Friday. Speaking to reporters, Naresh said, "I had earlier said that I will stand with whatever call the party takes to choose a candidate. But I asked them to pick one who is a dedicated worker of the Congress instead of the one who used to campaign for the BJP and believes in RSS ideology. I have the blessings of all the people in Deoli-Uniyara and I will close the business of such people."

Slamming Tonk MP Harish Meena, he added: "He has sold the tickets. He was the one who recommended the names of the probable candidates and he preferred a leader who shared BJP's ideology."

The Congress on Saturday roped in senior party leader Prahlad Gunjal and Hindoli MLA Ashok Chandna to have a dialogue with him and convince him to withdraw his nomination, said a party functionary requesting anonymity.

Party chief Govind Singh Dotsara said, "Naresh Meena came to our war room on Thursday and we had a meeting for an hour. He promised that he would prepare for the elections in Chhabra assembly in future and will not go against the party. We have no idea why he changed his mind suddenly."

**JAIPUR:** A 53-year-old French tourist died in a hotel room in Jaipur on Saturday, police said.

Georges Sylvie, who arrived in Jaipur as part of a troupe two days ago, had been experiencing uneasiness from Thursday and consulted a doctor, Kotwali SHO Sawai Singh said. The hotel staff informed police that Sylvie died in his room late on Friday.

The body has been sent to the mortuary of a government hospital and Sylvie's family has been informed. As she was a foreign national, all the necessary protocols are being followed, Singh said.

## Meena misled people to get a ticket for his brother: Dotsara

**JAIPUR:** Agriculture minister Kirodi Lal Meena has been misleading people with his resignation from the Bharatiya Janata Party (BJP)-led state government three months ago, only to manage a ticket for his brother in the upcoming bypolls, Congress state chief Govind Dotsara said on Saturday.

"He is the one who floated his resignation three months ago, and started protesting against the work of his own government. But everything was for a ticket for his brother. He has been misleading people throughout the last three months. All his resentment vanished the moment his brother got a ticket from Dausa," said Dotsara while addressing a rally in Churu to unveil the statue of farmer Kumbharam Chaudhary Arya.

On September 19, the BJP declared its first candidate list for the upcoming bypolls to be held at the seven assembly seats in Rajasthan. Meena's brother Jagamohan Meena has been

fielded from Dausa (ST) seat, following which the Congress levelled an allegation of "nepotism" against them.

Kirodi Meena resigned from the cabinet soon after the general elections in June, in which the party lost 11 seats to the Congress-led INDIA bloc. Of the 11 seats, five were from eastern Rajasthan where Meena had campaigned voraciously.

Meena said that he submitted his resignation considering his weakening influence in the state, but the cabinet did not take any decision on it till date.

Taking a dig at Meena, Dotsara also said, "Leaders like him talks about people and their issues only for their own interest. Nobody thought that he would become the agricul-

ture minister. But, once he became the agriculture minister, he is the one who said that the farmers made it a habit to take loans and that so they should not be given loans. Farmers will never forget it."

He said, "The BJP leaders are habituated in delivering speeches during the election, provoking people to think in line of casteism and communalism. They did it during Rajasthan state polls when people seemed happy with the work of the Congress and also repeated the same in the Haryana election as well. But they never keep the commitments they promise people as we can also see in our state." Addressing the rally, Dotsara also stated that the farmers don't have any caste or community.

Reacting to Dotsara, BJP state chief Madan Rathore said, "There is no nepotism. The party gave ticket to the ones who are potent. Everybody is part of one family called the BJP. We are also fighting the election together. Dotsara should see the condition of his own party before reviewing us."

## Revenue officer found dead, suicide suspected

**BHARATPUR:** A 44-year-old revenue officer (Naib tehsildar) was found dead in front of the Karauli collectorate office early on Saturday. Police suspect it to be a case of suicide, officers aware of the matter said.

"The deceased is from the Bharatpur district and was transferred from Dholpur to Karauli just five days ago. He was found hanging from a tree at the collector's office on Saturday," said Karauli superintendent of police Brijesh Jyoti Upadhyay.

He added that the incident came to light when the local residents spotted the body when they went to the city park for a morning walk, and informed police immediately.

"Police reached the spot and pulled down his body and took it to the district hospital, where doctors declared him brought dead," said the SP.

Police recovered a note from his pocket where he purportedly apologised to his family

for ending his life and added that he took the extreme step as he was under stress due to some ailments, said police.

Earlier, he was posted as the Naib tehsildar in Dholpur, and was transferred to Karauli five days ago.

Police handed over the body to the family members after the post-mortem examination. His brother said, "He was a patwari and was then promoted to the posts of revenue clerk officer and naib tehsildar."

"He is survived by his wife and two daughters. Initial probe reveals that there was no family dispute or financial distress. Further investigation is on," said the SP.
